



CODE OF CONDUCT

Acusensus Limited ACN 625 231 941 (Company)

1. Objectives

This Code of Conduct has been established by the board of directors (**Board**) of the Company and applies to all Personnel of the Company. The Company is committed to complying with all applicable laws and regulations and to delivering strong returns and shareholder value while also promoting shareholder and general market confidence in the Company. The Company is also committed to acting ethically and responsibly in its dealings with third parties. The Code of Conduct sets out the Company's values which have been developed to give all employees a clear and defined way to act and is designed to set out the practices which are necessary to maintain our stakeholder's confidence in the Company's integrity.

In this Code of Conduct, **Personnel** means a director (executive or non-executive), officer, employee, authorised representative, contractor or consultant of the Company or of its subsidiaries. The objectives of this Code of Conduct are to ensure that:

- 1.1 high standards of corporate and individual behaviour are observed by all Personnel;
- 1.2 Personnel are aware of their responsibilities to the Company; and
- 1.3 all persons dealing with the Company, whether it be Personnel, shareholders, suppliers or competitors, can be guided by the stated values and practices of the Company.

Any reference to "**shareholder**" in this Policy includes holders of shares, options and other securities of the Company.

The Company is committed to complying with this Code of Conduct and requires all Personnel to comply with it. Personnel must comply with both the spirit as well as the letter of all laws and regulations which apply to the Company and the principles of this Code of Conduct. Further, Personnel should always use due care and diligence when fulfilling their role or representing the Company and should not engage in any conduct likely to bring discredit upon the Company.

2. Statement of Values

The Company aims to instil and continually reinforce a culture within the Company of acting lawfully, ethically and responsibly. For this purpose, all Personnel are expected to act in accordance with the Company's statement of values, which sets out a clear and defined way we expect all Personnel to act and which are central to how our organisation does business. - 2.1 Impact – the Company is driven by its mission to develop and deliver solutions that make a positive and sustainable impact, creating safer communities across the globe;
- 2.2 Collaboration – the Company believes that solutions to any big challenge are best discovered through collaboration. The Company knows it is more effective and innovative when it encourages and values different ideas, skills and perspectives allowing it to deliver customer-centric, tailored solutions;
- 2.3 Integrity – the Company prides itself on conducting its business ethically and responsibly. The Company keeps its word, it delivers on its promises and it strives to earn the trust of its clients to support them in delivering on their unique public policy and business objectives; and
- 2.4 Care – ensuring the safety and wellbeing of the Company's employees, its customers and the community drives the Company to deliver innovative and superior solutions.

3. Conflicts of Interest

A conflict of interest occurs when a Personnel's interests interfere, or appear to interfere, with the Company's interests. The Company expects Personnel to act honestly, with high standards of personal integrity and in good faith at all times and, in a manner which is in the best interests of the Company as a whole and that would not negatively affect the Company's reputation.

Personnel will conduct their personal activities in a manner that is lawful and avoids possible, actual or perceived conflicts of interest between the Personnel's personal interests and those of the Company. Personnel (other than directors) must promptly disclose to the Managing Director / CEO or any member of the Executive Leadership Team (**Reporting Person**) any actual or potential conflict of interest of which they become aware. Directors (executive and non-executive) must promptly disclose to the Board any actual or potential conflict of interest of which they become aware. Any conflicts of interest must be dealt with appropriately.

4. Corporate Opportunities

Personnel will not:

- 4.1 take advantage of the property or information of the Company or its customers, or their position or opportunities arising from these, for personal gain or to cause detriment to the Company or its customers;
- 4.2 use the Company's assets and property (including the Company's name) or information for any purposes other than lawful purposes authorised by the Board;
- 4.3 enter into any arrangement or participate in any activity that would conflict with the Company's best interests or that would be likely to negatively affect the Company's reputation;
- 4.4 disclose any of the Company's information, except where disclosure is permitted or required by the Company's Constitution, law or ASX Listing Rules; or
- 4.5 offer or accept bribes, inducements, commissions or misuse company assets and resources.

5. Trading in Securities

Personnel will ensure that all trading in securities, including trading in securities of the Company, is in accordance with the Company's Securities Trading Policy. The purpose of the Securities Trading Policy is to ensure compliance with the law and to minimise the scope for misunderstandings or suspicions regarding Personnel trading in securities while in possession of non-public price sensitive information.

6. Confidentiality

Personnel will maintain and protect the confidentiality of the Company's information, except where disclosure is allowed by the Board or is required by law.

Personnel will not make improper use of any information acquired by virtue of being an employee, including the use of that information for personal gain or the gain of another party or in breach of a person's privacy.

7. Responsibilities to key stakeholders

Personnel will always deal with shareholders, customers, suppliers, competitors and other Personnel in a manner that is lawful, ethical, diligent and fair and with honesty, integrity and respect.

8. Compliance with applicable laws, regulations, rules and policies

Personnel will always act in a manner that is compliant with all laws and regulations that apply to the Company and its operations.

Personnel will act in compliance with this Code of Conduct and the Company's other policies. Personnel will also work in a safe and compliant manner and to observe all workplace health and safety rules and responsibilities.

Personnel will not knowingly participate in any illegal or unethical activity.

Personnel shall report any actual or potential breaches of law, this Code of Conduct or the Company's other policies to a Reporting Person, or where deemed appropriate, the Company's Audit and Risk Management Committee. If ever in doubt, Personnel should seek advice immediately from the Company's General Counsel.

9. Employment Practices

The Company aims to provide a work environment in which all Personnel can excel regardless of race, religion, age, disability, gender, sexual preference or marital status. The Company will from time to time maintain various policies relating to the workplace, including the Company's Diversity & Inclusion Policy and Equal Employment Opportunity & Anti-Discrimination Policy. Personnel should familiarise themselves with these policies and ensure that they comply with them.

The Company will provide, and all Personnel are expected to participate in, appropriate training on their obligations under this Code.

10. Reporting Concerns

The Company requires all Personnel who become aware of an actual or suspected violation of this Code of Conduct to report to a Reporting Person. The Company will ensure that Personnel are not disadvantaged in any way for reporting violations of the Code of Conduct or other unlawful or unethical conduct and that matters are dealt with promptly and fairly.

Upon:

- 10.1 receipt and investigation of a notification of an actual or suspected violation of this Code of Conduct; or
- 10.2 any reported violation that constitutes a material breach of this Code,

the relevant Reporting Person shall escalate the complaint for further investigation or action to the Board.

The Company also maintains a Whistleblower Policy that may be relevant to reporting breaches of the Code of Conduct, which Personnel should also familiarise themselves with.

11. Compliance

The Board is responsible for monitoring compliance with this Code of Conduct. Any queries in relation to this Code of Conduct should be referred to a Reporting Person.

Failure by Personnel to comply with this Code of Conduct may result in disciplinary action, including in serious cases, the termination of employment.

12. Review

This Code of Conduct will be reviewed by the Board annually to ensure that it is operating effectively and whether any changes are required to the Code of Conduct.
